The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Basic Services of Funeral Director and Staff

Our fee for the services of funeral director and staff includes, but is not limited to, staff to respond to initial request for services; arrangements conference with family or responsible party; arrangement of funeral; preparation and filing of necessary authorization and permits; recording vital statistics; preparation and placement of obituary notices; staff assistance prior to, during and following, coordination with those providing other portions of the funeral, e.g. cemetery, crematory and others. Also included in these charges are overhead expenses relative to our facility such as insurance, maintenance, and utilities expenses, secretarial and administrative cost, equipment and inventory cost.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains).

Embalming

\$395.00

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Receiving of Remains From Another Funeral Home **\$1,295.00**

This charge includes temporary shelter of remains, transportation of remains to cemetery and necessary services of staff. This charge does not include visitation, rites or ceremonies.

Immediate Burials **From \$1,295.00 to \$10,795.00**

Our charge for an immediate burial (excl. ceremony, visitation & cemetery charges) includes local removal, care of remains, basic services of staff, authorizations & casket coach to local cemetery.

Direct Cremation **From \$1,080.00 to \$3,775.00**

Our charges for a direct cremation without an attendant, rites or ceremonies includes local removal of remains, cremation fee, necessary services of staff and authorization. State and local law do not require a casket for direct cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are corrugated fiberboard and hardboard.
